

EXPRESSION OF INTEREST (including Pre-Qualification Requirements)

Supply of Wellbore Completions Equipment and Services

Overview:

- Hibernia Management and Development Company Ltd. (HMDC), and ExxonMobil Canada Properties, by its managing partner, ExxonMobil Canada Ltd. (ExxonMobil) are in the process of pre-qualifying experienced companies (“Contractor or Vendor”) that can supply Wellbore Completions Equipment and Services for their onshore and offshore Newfoundland and Labrador requirements.
- Contractor shall provide all management, personnel, processes, materials, tools, equipment, applicable certifications and facilities as may be required to ensure all equipment covered by this pending contract shall be fabricated and supplied to meet all statutory requirements, codes of practice and applicable specifications.
- The intention is to have this scope of work cover the requirements of the Hibernia Project*. For clarity, the scope of work includes not only the foregoing, but may include at ExxonMobil and/or HMDC’s discretion, future work related to minor changes to the scope of work described herein, in which ExxonMobil and/or HMDC may engage onshore or offshore Newfoundland and Labrador, for oil and gas facilities as well as potential exploration or subsea related activities.
- While not planned, it should be noted that any resulting Non-Binding Request for Proposal (“NRFP”) and contract may require inclusion of and/or extension to other operators in the area, project co-venturers, contractors and/or affiliated companies.
- ExxonMobil and HMDC support providing opportunities to Canadian, and, in particular, Newfoundland and Labrador companies and individuals, on a commercially competitive basis. Contractors expressing interest in providing services or materials, if they are selected to bid, will be required to complete a Canada-Newfoundland and Labrador Benefits Questionnaire at the bid stage.
- ExxonMobil and HMDC encourage the participation of members of designated groups (women; Indigenous peoples; persons with disabilities; and members of visible minorities) and corporations or cooperatives owned by them, in the supply of goods and services.

Scope of Work Overview:

The scope of work/supply includes, but is not limited to:

Drilling & Completions Overview:

- The anticipated scope includes Platform and potential subsea wellbores
- Platform Wellbores will be drilled from the Hibernia Platform; subsea wellbores will be drilled from a MODU
- Wellbores will have three-dimensional trajectories including long horizontal sections requiring extended reach drilling (ERD) profiles.
- Project may consist of:
 - Oil Producer wellbores with either cased and perforated or open hole completions and gas lift completion designs
 - Water injection wellbores with either cased hole or open hole completions
 - Gas injection wellbores with either cased and perforated or open hole completions
 - Water and gas alternating injection wellbores
 - Multi-lateral wellbores
 - Intelligent Well Completions as part of a single bore or multilateral concept
- Further detail on well environment and loading conditions as well as quality requirements will be provided in technical scope of work in the bid phase.

The scope of work/supply includes, but is not limited to:

- Supply, operation, storage, and maintenance of well completion equipment
- Facilities for the pre-assembly, maintenance and testing of completion components
- Provision of qualified onshore and offshore personnel to coordinate and conduct technical and operational (deployment) activities;
- Participation in the planning and design of all wells, completions, and well workovers in accordance with the contract scope;

Additionally, any selected Contractors will be required to meet all technical and Safety, Health, Environmental, and Security (SHE&S) specifications and safe work practices of ExxonMobil, HMDC and their affiliates as appropriate.

Minimum Technical Requirements are as follows:

- Contractor to demonstrate how they will provide the scope described above and how they have provided such scope previously, specifically in Eastern Canada.
- Personnel experienced in completions operations and familiar with own completions equipment and associated tools in an offshore environment. Minimum of 5 years' experience preferred. Crew complement and experience to be reviewed and approved by ExxonMobil and HMDC.
- Sufficient warehouse and maintenance shop space to support the work summary shown in the Scope of Work Overview above. This warehouse and maintenance shop should be located in St. John's, NL or the surrounding area.

Submission Requirements

Vendor or Contractor submissions in response to this Expression of Interest (EOI) (including pre-qualification) **must** include the afore-mentioned reference number, as well as the following information:

1. Completed ExxonMobil / HMDC Vendor SSHE pre-qualification questionnaire. (Available through BIDS – see contact information below.)
2. Completed ExxonMobil / HMDC QA/QC pre-qualification questionnaire. (Available through BIDS-see contact information below.)
3. Information demonstrating qualification for the Scope of Work & minimum technical requirements as detailed above.
4. Describe your experience operating under and familiarity with, the benefits provisions of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Act and your experience with any similar regimes in other parts of Canada or internationally. At the NRRFP stage, proponents will be required to indicate how they comply with the above.
5. Please acknowledge that responsible management personnel have read, understand and will support requirements to comply with the following where applicable
 - i) Section 45 of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Act.
 - ii) The Hibernia Benefits Plan, the HSE Benefits Agreement and HSE Benefits Plan
 - iii) The Exploration Benefits Plan

Submitted information is to be provided in separate PDF (or native file) submissions and not submitted as one combined file. Please be aware that ExxonMobil / HMDC is limited to a 10MB file size for receiving e-mail.

The data submitted in response to the aforementioned questionnaires will be used to evaluate your company's ability (and those of your preferred sub-contractors / vendors where applicable) to perform these services or provide these materials.

It will focus primarily on:

- Past safety performance
- Applicable experiences
- Project execution skills
- Project management & integration skills
- Available technologies with proven performance
- Current capability
- Personnel qualifications
- Financial capacity

We will evaluate this data and develop a final group of vendors who will be asked to submit formal competitive bids. We reserve the right to make the final determination of which Contractors will receive the NRFP and which Contractor will be awarded the final contract.

This EOI is not a pre-qualification of Contractors for other ExxonMobil / HMDC work, but is limited to the scope aforementioned. In addition, participation in this EOI, including any statements whether oral or written between ExxonMobil / HMDC and your company, shall not create or be deemed to create any binding legal relationship or contract, or be construed to do so between ExxonMobil / HMDC and your company. All costs associated with the preparation of your response to this EOI shall be at your expense.

This EOI (Including Pre-qualification) may or may not result in the issuance of an NRFP and may or may not result in the award of a contract. If you respond to this EOI and your company is selected to be on the list of proponents, your company name, your designated company representative's name and business contact information may be posted on public websites. Similarly, if you are selected for award, the same information may also be posted, indicating that the work has been awarded to your company.

At the sole discretion of HMDC and ExxonMobil, the scope of work may or may not be split into smaller scopes to best suit our requirements. HMDC and ExxonMobil reserve the right to issue more than one RFP/ITT and/or award more than one contract.

* It should be assumed that the Hibernia Project includes, but is not limited to, current and planned Hibernia and Hibernia Southern Extension operations as well as future development on behalf of Hibernia (operated by Hibernia Management and Development Company Ltd.) and/or Hibernia Southern Extension participants (operated by ExxonMobil Canada Properties).
