Overview:

 to minor changes to the scope of work described herein, in which HMDC and/or EMCP may engage onshore or
 offshore Nova Scotia and Newfoundland and Labrador, for oil and gas facilities as well as exploration or subsea
 related activities.

At the NRFP/ITT stage, bidders will be required to indicate how they comply with the above.
